Procedure: Examine steering column/wheel. 1. Inspect the steering column for any looseness in bolts, clamps, positioning parts, or universal joints. Inspect the flexible coupling in the steering column (if the vehicle is so equipped) for excessive misalignment and tightness of the clamp bolt or nut.
