According to the PRC Criminal Law, corporate liability arises when: (i) a unit crime has been committed; (ii) a unit is preparing for a crime; and (iii) a unit has already begun to carry out a crime but the crime is not consummated because of factors independent from the will of the unit. We believe that if the criminal conduct is voluntarily extinguished, the corporate criminal liability will also be extinguished.
